

Retreat Agreement

The following Terms and Conditions are established to provide clear expectations and guidelines to help our guests prepare for a safe and meaningful retreat experience, both within ceremonies and in the retreat as a whole.

The ayahuasca, San Pedro, and Kambo served at the Retreat are used in accordance with traditional Amazonian and Andean practices, under the guidance of experienced local shamans. Our facilitators and shamans determine the appropriate use and dosage for each participant to ensure safety and integrity throughout the process.

Ayahuasca can induce a range of experiences including visual phenomena (abstract patterns or vivid scenarios), emotional highs and lows, resurfacing of suppressed memories, paranormal experiences, and deeply introspective or transpersonal states. You may face unresolved fears or emotional challenges, and some experiences may result in physical discomfort.

Physical effects may include nausea, vomiting, chills, ringing in the ears, dizziness, diarrhea, tremors, sweating, ataxia, or fainting. Lack of visions does not indicate the medicine is ineffective; ayahuasca often works on subtle, non-visual levels. The experience is often non-linear, alternating between challenging and euphoric phases. Ayahuasca works by helping you confront and integrate unresolved trauma, emotional wounds, or energetic blockages. It is common to experience psychological or physical discomfort during and after ceremony, as part of this healing process.

Our facilitators and healers are dedicated to ensuring your physical and emotional safety and privacy. We provide ongoing support throughout your preparation, during ceremonies, and in the integration phase. Emergency protocols are in place and assistance will be provided when necessary.

Participation in ceremonies is entirely voluntary. You may choose to opt out prior to the start of a ceremony. However, for your own safety, you must follow all instructions provided by our facilitators and healers at all times. Facilitators and healers may withdraw

your participation from ceremonies at any point if your physical or mental health is deemed at risk, or if you no longer meet participation criteria.

Ayahuasca is not a replacement for professional medical, psychiatric, or therapeutic treatment. If you are undergoing treatment or taking medications, you must disclose full details before booking. All participants must complete a comprehensive medical form and health questionnaire, answering truthfully and thoroughly.

The Organizer does not guarantee any particular outcome, healing, insight, or spiritual experience. Every participant's journey is individual and results may vary widely.

Terms and Conditions

Medical and Psychological Screening

- You must fully disclose your medical and psychological history prior to booking and promptly notify the Organizer of any changes.
- Participation requires completion of all medical forms and questionnaires honestly and completely.
- The Organizer has final authority over your participation in ceremonies and may adjust doses or deny access to plant medicines for safety reasons.
- You must be physically and mentally fit to participate. You join ceremonies at your own risk.

Conduct and Safety

- The Organizer may require drug or breathalyzer testing at any time without prior notice. Refusal may result in immediate expulsion without refund.
- Possession of unauthorized prescription drugs, alcohol, or illegal substances will result in denial of participation or removal from the retreat, without refund.
- Sexual activity during the retreat is discouraged, including between spouses. If a romantic connection arises, you are asked to observe a period of personal reflection before engaging physically.
- While mobile phone use is allowed, participants are encouraged to minimize usage to support deep inner work and presence.

- You are strongly encouraged to abstain from eating meat for at least two weeks prior to the retreat.
- Participants must remain on the retreat premises for the full duration unless otherwise authorized.
- The Organizer may expel any participant who jeopardizes the safety or harmony of the group, with or without prior warning, and without refund.
- In case of a medical emergency, you will be accompanied to a local facility.

Payment & Cancellation Terms

Payment Terms – Amount

If my application is approved (typically within 1–4 days), I will receive an confirmation email along with a secure payment link to finalize my booking. At that time:

- If the retreat begins in more than 6 weeks, I may choose to pay a 50% deposit.
- If the retreat begins in 6 weeks or less, full payment is required.

If, for any reason, my application is not approved, no payment will be processed. By submitting this form, I understand that my place is not secured until payment has been completed.

m Payment Terms - Final Payment

I understand that full payment must be received no later than 6 weeks before the retreat start date in order to confirm my participation. If I selected the 50% deposit option when booking, the Organizer will email a payment link for the remaining balance no later than 6 weeks before the retreat start date. Timely payment is required to confirm participation.

All payments must be made in USD. Any applicable currency conversion fees or international transaction charges are the responsibility of the participant.

X Guest Cancellation Terms

- If I cancel more than 6 weeks before the retreat, I may receive a refund minus a \$250 administrative fee, or transfer my payment to a future retreat.
- If I cancel within 6 weeks of the retreat start date, no refund or transfer will be provided unless my place is filled by another guest.

- If I do not attend the retreat without prior written notice ("no-show"), I understand that no refund or credit will be issued.
- Late arrivals do not qualify for partial refunds or credits.
- If I leave the retreat early for any reason, no refund will be provided.
- I may request to transfer my booking to another eligible participant, provided the Organizer approves the transfer and the new participant completes the full medical screening no later than 2 weeks prior to the retreat start date.

Retreat Cancellation Terms

- In the unlikely event that the retreat must be canceled due to unforeseen circumstances beyond the Organizer's control (e.g., natural disasters, pandemics, border closures, civil unrest, or governmental restrictions), all payments made will be either:
 - Converted into a personal credit, valid for use toward any future program within 1 year,
 - Or fully refunded, at my discretion (unless otherwise prevented by circumstances).
- The Organizer is not responsible for any non-refundable expenses incurred by participants, such as flights or travel insurance.

⚠ Force Majeure

The Organizer is not liable for any failure to perform or delays in performance due to force majeure, including but not limited to: natural disasters, fires, floods, strikes, war, terrorism, epidemics, pandemics, government actions, or other events outside of the Organizer's reasonable control. In such cases, standard refund policies may not apply, and credit toward future retreats may be issued at the Organizer's discretion.

Legal Disclaimer: Peruvian Law Compliance

Under Peruvian Law (Ley N $^{\circ}$ 28538, Article 290): "Any person simulating a doctor or health care professional without a professional title will be punished with incarceration of no less than one year and no more than four years for engaging in:

- 1. Advice, diagnosis, prescription, or administering or applying any means intended as health care, even if offered without charge.
- 2. Issuing tests or information to support such advice, diagnosis, prescription, or administration."

This retreat is not a medical facility, and no health care services are provided or implied. The owners, staff, and healers are not licensed health care professionals and do not offer:

- Medical advice, diagnosis, prescription, or administration of any health-related treatment even if offered without charge.
- Tests or information intended to support such medical actions.

Ceremonies are conducted strictly for spiritual and traditional purposes. Participation is at your own discretion and risk.
